

# PRIVACY NOTICE PURSUANT TO ART. 13 EUROPEAN REGULATION 2016/679 ("GDPR")

For the **establishment and execution of contractual relationships with its business partners**, the Company (whose details you will find below) needs to collect common personal data relating to individuals acting within the corporate organization of such partners.

Thus, we invite you to carefully read this information which describes the purposes of use of such data and the rights guaranteed by Regulation (EU) 2016/679 ("Regulation" or "GDPR")

## DATA CONTROLLER

The **company** with which you have entered into a **contractual relationship**. The details of each company (including the registered office) are available at page 3 of this document.

### What is its role?

Data Controller is who determine the purposes and methods of use of personal data.

## DATA PROTECTION OFFICER\*

Contact information for the DPO, if the company has appointed one, can be found on page 3 of this document.

### What is its role?

Data Protection Officer oversees compliance with privacy regulations and serves as the point of contact for requests from the individuals to whom the personal data refers.

## WHAT DATA IS PROCESSED?

Common personal data of employees and/or contractors, company contact persons and legal representatives such as:

-  **Name and surname;**
-  **Contact data** (email address and/or phone number).

## WHY DO WE PROCESS THE DATA AND FOR HOW LONG?

**Purpose #1:** Establishment and execution of the contractual relationship

**What authorizes us to process the data?** Execution of a contract/pre-contractual measures at your request (*art. 6 par. 1 letter b) GDPR*)

**For how long?** For the duration of the contract and for 10 years thereafter

**Purpose #2:** Management of administrative and tax compliance (e.g. invoicing).

**What authorizes us to process the data?** Fulfillments of legal obligations on us (*art. 6 co. 1 lett. c) GDPR*)

**For how long?** For the duration of the contract and for 10 years thereafter

**Purpose #3:** Establishment, exercise or defense of one of our rights, in or out of court.

**What authorizes us to process the data?** Legitimate interest in defending ourselves or exercising our right (*art. 6 co. 1 lett. f) GDPR*)

**For how long?** Until the judgment or out-of-court proceedings are settled

## CAN YOU CHOOSE WHETHER OR NOT TO GIVE US YOUR DATA?

If you decide not to provide us with your data, we may **not be able** to fulfill our contractual obligations.

## DO WE DISCLOSE, COMMUNICATE, OR TRANSFER YOUR DATA?

Your data will **not be disclosed**, but may be communicated to our **consultants and/or suppliers**, and will be processed by our **staff**.

Moreover, if needed and as required by law, we may communicate them to **public authorities**, upon express request.

We may transfer your data outside of the **European Union**; however, this will always be done in compliance with the guarantees provided by the GDPR.

## ARE YOU AWARE OF YOUR PRIVACY RIGHTS?

Below you will find listed the specific privacy rights you can exercise in relation to the processing activities contained in this policy.



### RIGHT OF ACCESS

You have the right to know if there is any processing of data concerning you, and if so, to obtain a copy of such data. You also have the right to be informed about: the origin of the data, the categories of personal data processed, the recipients of the data, the purposes of the processing, the existence of automated decision-making (including profiling), the data retention period, and the rights recognized to you by the GDPR.



### RIGHT TO RECTIFICATION

You have the right to obtain rectification or integration if your data is inaccurate or incomplete.



### RIGHT OF ERASURE

You have the right to request that your data be erased if they are no longer necessary or if the Company is no longer authorized to process them.



### RIGHT TO RESTRICTION OF PROCESSING

You have the right to obtain the limitation of processing when you have contested the accuracy of personal data, for the period during which we carry out our checks; we are not authorized to process your data and, instead of requesting their deletion, you can request to limit their use; if the data we hold - even if they are no longer necessary for the purposes of the processing for which they were collected - are necessary for you to establish, exercise or defend a right in court.



### RIGHT TO OBJECT

You have the right to object at any time, for reasons related to your particular situation, to the processing of your personal data based on our legitimate interest as the Controller. Upon receipt of your request, we will refrain from processing your data unless there are compelling legitimate grounds that override your interests, rights, and freedoms or for the establishment, exercise, or defense of legal claims.

Furthermore, if you believe that the processing of your personal data is carried out in breach of the provisions of the GDPR, you have the **RIGHT TO LODGE A COMPLAINT** with the competent supervisory authority for data protection
